- 2. All attending pets must be healthy, free from parasites & have all necessary shots including: Rabies, Bordetella & Distemper for dogs, and FVRCP for cats Flu Vaccine HIGHLY recommended.
- 3. ALL PETS MUST BE ON A 6-FOOT LEASH AND IN THE CONTROL OF THEIR OWNER AT ALL TIMES.
- 4. A maximum of 1 pet per adult will be permitted.
- 5. Owners are responsible for bagging and disposing of any waste created by their pet.
- 6. No dogs in heat will be permitted.
- 7. Dogs displaying excessive barking, bullying, or aggression are not permitted.
- 8. NO selling of pets of any kind will be tolerated.
- 9. If aggressive behavior or an escalated situation is observed, UP Pet Fest team members reserve the right to reposition involved dogs and may ask owners and their dogs to leave the premise. If asked to leave by staff, owners agree to follow those instructions without argument.

Waiver of Liability

- Owners consent to their likeness and the likeness of their pet and all members of their party being photographed or recorded for any purpose while on UP Pet Fest premises, and permit D&D Dog Dynamics and all organizers of the UP Pet Fest the right to use said media for any and all promotional purposes as they see fit, and also agree that D&D Dog Dynamics will retain sole ownership of all said photographs or recordings.

- I further agree to indemnify and hold harmless the Released Parties from any claims, rights or causes or actions which may accrue to any individual or entity participating in, involved with or present at the Event as a result, directly or indirectly, of my own acts or omissions, or the acts or omissions of my pet, during my participation in or association with the Event, including travel to and from the Event, and that I shall indemnify the Released Parties for any damages awarded or expenses incurred as a result of any such claims, rights or causes of action, including, but not limited to, attorney fees and court costs
- I accept all liability for damage to property or persons caused by myself or my pet(s). I understand that this Release Agreement is a contract, which has legal consequences and state that I have read all of its terms, fully understand them and am legally competent to execute this Release Agreement. This Agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any subsequent waiver of modification.
